Clinical Assessment and Practical Interventions Day 1 and Day 2

Course Description for September 15th & 16th

This course will present an overview of the components of praxis with an emphasis on clinical assessment and intervention of praxis problems in children using a sensory integration frame of reference. The impact of various praxis problems on functional performance will be highlighted. A framework for observing, assessing, clinical reasoning, and identifying ideation, motor planning, sequencing, bilateral coordination and projected action sequence problems within a sensory integration treatment model will be presented. A clinical observation-based assessment will be presented and used to develop observation skills and clinical reasoning in identifying and treating praxis problems. Practical intervention strategies using both top-down and bottom up approaches will be highlighted through video review, case studies, and lecture formats.

Level: This course would be appropriate for intermediate to advanced level OT, PT, OT aides/ assts, PT aides/ assts. A previous knowledge of sensory integration theory would be recommended.

Objectives: By the end of the course the participant will be able to:

1. Describe the underlying neural and sensory mechanisms of the various praxis dysfunctions
2. Observe, assess and differentiate the range of praxis dysfunctions from ideation to execution problems
3. Apply top-down and bottom up treatment principles appropriately to different praxis problems using clinical reasoning
4. Identify the ways various praxis problems impact on functional performance
5. Identify strategies and treatment plan for improving performance

Advanced Clinical Reasoning and Treatment Planning for Praxis Intervention Day 3

Course Description for September 17th

This advanced-level clinical reasoning course builds upon the clinical intervention knowledge gained in the course Clinical Assessment and Practical Interventions for Praxis: From Ideation to Execution and allows for development of advanced clinical reasoning and treatment planning skills for praxis intervention. A clinical reasoning model will be presented and through use of case studies and group discussion, participants will develop and refine their ability to create effective treatment plans for praxis problems. Participants are encouraged to bring case study information and videos for group discussion and problem solving. Those desiring to bring video for discussion must contact the speaker at least 2 weeks prior to the course to assure technical compatibility.

Learning Objectives At the end of the course the participant will be able to:

1. Identify praxis problems and select appropriate and effective intervention strategies and activities
2. Apply clinical reasoning to selection of activities to maximize impact of treatment
3. Create and apply effective treatment plans for praxis problems

Contact Hours: 6 contact hours

Participants: OT/ OTA, PT/PTA and Speech with extensive knowledge of sensory integration.
